#### **Finally Free**

Once deemed a "menace to society," she got sober in jail, did her time and is now going back in to help others It was the summer of 1986, on the last day of seventh grade, when I experienced my first blackout. I was 13 years old. I drank a half pint of grain alcohol and was arrested in our local supermarket for indecent exposure. This would be my pattern. Get blackout drunk, get arrested, rinse and repeat.

Many years later, after my last drunk, I remember slowly opening my eyes and looking around a hospital room and seeing figures of people passing by the door. As I tried to lift myself up, I realized I was restrained to a hospital bed. I was on a ventilator. I immediately sank back onto the bed completely disappointed that I even woke up.

The night before had been Superbowl Sunday, and the whole city was celebrating the Broncos' victory. I had just gotten "86'd" out of a bar and wanted to die. I was in significant trouble with the law, unemployable and had ruined every relationship that meant anything to me. I wanted it all to end. Alcohol had finally defeated me. I had taken a bottle of tranquilizers to calm my mind and a bottle of muscle relaxers to stop my heart, washed them all down with a bottle of whiskey and slipped away into the abyss. I have not had a drink since that day.

Just five weeks earlier, two days before Christmas, I drove my oldest son's brand-new car into a ravine and got my fifth and final felony DUI. When I woke up in that hospital bed, I overheard the staff saying I would be heading to jail. My mind was racing. I knew I had to get out of there, so I did what any sane person would do: I pulled out my IV and took my EKG leads off, grabbed my belongings and away I went!

It was a frigid winter night. As I was walking to the nearest bus station, a flood of memories came to me like a tidal wave: the first DUI was right after I turned 21; the second was with my sons in the car (and two child-abuse charges to go along with it); the third I crashed two cars in a matter of four hours; the fourth I took my Interlock out of my car and somehow ended up in Breckenridge. Now the fifth—while on probation from DUIs three and four, wearing a scram unit, a GPS, a sleep-time watch and carrying a portable breathalyzer—would send me away for a very long time.

Another memory came to me as I was sobbing hysterically. I recalled that summer when I was in Jefferson County Jail. two women came into the pod and held an AA meeting. I'll never forget that meeting. One woman shared how she sat right where I was sitting and the other woman said, "You never have to feel this way again." As tears streamed down my face, I felt something stronger and more powerful than myself move through me.

I had always known of a God, but all I knew was to bargain with him and swear off one more time if he would just get me out of this mess. That night in jail, a seed was planted. I had been to many AA meetings in the past, usually only on the advice of a lawyer or as a probation requirement. To get away from a halfway house for a few hours, I would walk in the front door of an AA meeting, get my paper signed and walk out the back door. I heard people say that it takes what it takes, and for me it took one more DUI and a suicide attempt to bring me to acceptance and surrender.



In July of 2016, I was sentenced to four years in the Department of Corrections, with all previous convictions running concurrently. It felt like the judge punched me in the gut with his harsh but true words, "Ms. N-----, you are a menace to society."

I was and I knew it. What I didn't know was that my Higher Power was working in and through me as I worked the program of AA while awaiting my transport to jail. When I got to jail, I went to AA meetings inside, read the Big Book daily and did the Steps. I remember chasing down the guards to plead with them to listen to my Fifth Step, explaining that this had to be done so I wouldn't come visit them again.

After doing my Steps I could feel changes happening in me. My rage and anger were replaced with a pause; I had compassion for the other women around me (which I knew was an act of God because previously I just wanted to slap them in the face). I began having spiritual experiences amid my despair. Then nine months later, something miraculous happened. I got accepted into a community corrections facility and left the very next day.

Oh, to see daylight again, to feel the sun on my skin, to smell the fresh air, all the simple pleasures I took for granted for so long felt brand-new to me. My prayer the whole way to the halfway house was the Serenity Prayer —rinse and repeat.

As soon as I was able to leave there, I went to the clubhouse in Lakewood and the AA meeting there became my first home group. I went to any lengths to get to meetings. I rode my bike, took buses and the light rail to get to as many meetings as I could. My sponsor picked me up and took me through the Steps the way our book suggests. Soon I was eligible to move out into my own place. Only by the grace of God was I able to get out on the very day my son graduated from high school. I got to attend his graduation. What a gift.

Some time later I took a service position as our district's corrections chair. Today, corrections is my passion. I was even asked to be on a panel of speakers to share my experience, strength and hope at the 2021 Area 10 Corrections Conference. What an honor that was.

Life has gotten so much better, but hasn't been without its turbulence. A wonderful man who I called my spiritual mentor—he called himself my Eleventh Step sponsor—and whom I had deep admiration and love for passed away that March. Then five weeks later my baby sister died from this disease. I was blessed with the opportunity as a sober woman to write her obituary and read the eulogy at her service. And through it all, the thought of a drink never crossed my mind.

Recently—and it's probably the most meaningful gift of all—I was approved to bring AA meetings into the very jail where I first heard the message. So here I am. I got in the boat and stayed in the boat. I work this program one day at a time to the best of my ability and remarkable things have happened. Trust God, clean house, help another. Rinse and repeat.

**Current Month:** Checking and savings accounts are reconciled - total cash as of 5.31.24 is \$74,225 net of \$563 of sales tax leaves \$73,662 of available cash at 5.31.24.

Monthly revenues were \$7,796 (up significantly from last month, trending upward for the year) and monthly expenses were \$6,063 (way down from last month's extraordinary level, trending moderately downward) resulting in net income of \$1,733. Contributions were \$4,643 (trending upward for the year) and literature sales were \$2,965 (trending upward from the year).

**YTD (Year to Date):** As of May 31<sup>st</sup> 2024, with the year 41.67% complete, total revenues are \$40,529 which is 48.21% of the budgeted amount. Total contributions are at 45.85% of the budgeted amount, group contributions are at 43.90% of the budgeted amount and individual contributions are at 118.69% of the budgeted amount. Literature sales are at 53.81% of the budgeted amount - all revenue sources are running above the budgeted amounts.

The year to-date expenses are \$40,503, which is 48.21%, significantly more than budgeted amount which includes a very large literature purchased April.

The year-to-date income is \$26 vs the year-to-date net loss of (\$156) as of 5.31.23.

Tim made a motion to close, which was seconded by **Josh**; meeting adjourned at 6:21 PM.
